Articles of Association of The Gothic Hills Foundation

Last Amended January 1, 2019

The undersigned, a majority of whom are citizens of the United States do hereby certify that we agree to be and hereby are, organized under these Articles of Association, as a non-profit charitable organization, under the NTEE Classification System of "A19 - Nonmonetary support" to Arts, Culture & Humanities.

Article 1: Name of the Association

The name of the association is "The Gothic Hills Foundation".

Article 2: Offices of the Association

The principal office of the Association shall be at the home of the President of the Association, in the State of California, in the City of Los Angeles, in the County of Los Angeles.

Article 3: The purpose

The primary purpose of the Association is to enrich the community through entertainment events which collect and distribute charitable contributions from the public to other local non-profit organizations and is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 4: The officers & trustees

The names and mailing addresses of the persons who are the officers or trustees of the association shall be kept by register in the association's office, and will include the dates of joining the association and departure, if applicable. This register shall be kept up to date.

Article 5: Use of Earnings

No part of the net earnings of the association shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the association shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the association shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the association shall not participate in, or intervene in (including the

publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the association shall not carry on any other activities not permitted to be carried on (a) by a association exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a association, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 6: Assets upon dissolution

Upon the dissolution of the association, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the association is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 7: Fiscal Year

The Association shall operate with the calendar year as it's fiscal year.

Article 8: Members & membership

Official membership shall be closed and no party other than the board members shall be officially considered members of the Association. No membership dues will be required, and changes in membership shall require election by the existing members.

Article 9: Changes to these articles

These articles are considered to be our constitution or "bylaws" and may only be amended by majority vote of the entire membership.
